MINUTES FOR 90th MEETING OF THE GOVERNING BODY, BCAS

Before the start of the meeting, the house observed 1 minute silence for all those who lost their lives in the pandemic. Thereafter, Hon'ble Chairperson Ms. Madhuri Varshney welcomed all the members of the Governing body and wish all a safe and healthy life. She congratulated all the faculty and staff members who were promoted to next level in their respective career. She also suggested to look for generating resources for the institute in her remarks. Chairperson and Prof. Subho Mazumdar, on behalf of all the members, faculties and staff, also congratulated principal Prof. Balaram Pani for successfully completing one year as Dean of Colleges, University of Delhi.

Dr. Eram S. Rao(Vice principal), Dr. Sidharth Sirohi(Bursar) and Mr. Praveen Gupta (Account Officer, DHE) also attended the meeting as special invitee.

After due discussions and deliberations following are the minutes of the meeting.

ITEM NO. 1/ 90 : REPORT OF THE PRINCIPAL

The Principal informed the house in his report.

- i. The college has taken various COVID care management steps like sanitization of the campus, Thermal scanning of visitors, making available of masks and gloves to staff etc.
- ii. The college has also received a donation in the form of an Oxygen Concentrator from SEWA International and Covidcare4u coordinated by

- one of the faculty previously associated with the College, Mr. Kavinder Kumar.
- iii.** With a profound grief and sorrow, he informed the house that we lost wife of one of our faculty member, at the age of 35 only, because of COVID only. The college tried but did not succeed. Various staff members got infected and presently all have recovered partially or fully with the COVID-19.
 - iv.** Six students of the college also lost their respective Mother/ Father in Covid-19 pandemic. The college also paid Homage to some DHE officials and its Bank's staff members who lost their lives in this pandemic. Staff and students pay sincere condolences to their respective families.
 - v.** The college has successfully executed due promotions of faculty of the Stage I (9 cases for AL 10 to 11), Stage II (20 cases for AL 11 to 12) and Stage III (13 cases for AL 12 to 13A i.e. Associate Professor) has been completed. No such applications are now pending with the office.
 - vi.** The college has made a history in the University of Delhi to have the first ever Professors in the college. We have also promoted 4 Associate Professors (AL-13A) to Professor (AL 14) so far.
 - vii.** In addition the college had also successfully carried out Modified Assured Career Progression (MACP) of 5 non teaching staff members for financial upgradation.
 - viii.** The college offered special gratitude to the Chairperson Madam to extend her cooperation in carrying out task which was pending since more than 12 years. Member Secretary also thanked all the GB members, University teachers and administration for the same. He also expressed his thankfulness towards the Vice-Principal, SO Admin for the extended support and managing the entire exercise of promotion.
 - ix.** The college placed on record the appreciation of the contributions made by its University representatives Prof Rita Kakkar and Prof. Vishnu Bhatt who have completed their respective term in the GB.
 - x.** He also formally welcomed its new University Representatives Prof. Subho Mazumdar and Prof Manoj Kr. Singh, though they attended the last emergent GB.
 - xi.** The college has completed Assignment Based Practical Examinations for II-III years. Open Book Examinations are currently going on for III year students. Online classes for the I yr students are currently going on MS Teams.
 - xii.** All the members were apprised that some portion of the boundary wall of the college near the gate has started sinking, tilting and was damaged due to rainfall and heavy storm occurred on May 21 and May 30, 2021. The same to be looked on an urgent basis for obvious security reasons and other building maintenance works also require urgent attention.

- xiii. The college has applied for the National Institutional Ranking Framework (NIRF) ranking and also for the India Today ranking this time. The college has also participated in the DU QS World ranking. Now the college is preparing for the NAAC accreditation Cycle II next year. AQAR of all previous years have been uploaded.
- xiv. A committee constituted by the Department of Physical Education and Sports Sciences, University of Delhi, visited the college on June 4, 2021 for exploring the possibility to start the B.Sc. (Physical Education, Health Education and Sports) at Bhaskaracharya College of Applied Sciences.
- xv. The college has also applied for the DBT Star status for all the remaining departments viz; Botany, Zoology, Chemistry and Polymer Science. That will brought all the science departments under the scheme.
- xvi. The college is planning to run online short term courses with No Profit- No Loss basis or without any financial liability on the college, as it will be beneficial for NAAC and other accreditation. Presently one course in under process and three will start shortly.
- xvii. The college has also collaborated with Government College Bomdila, Arunachal Pradesh under the Vidya Vistar Scheme (V2S) of the University of Delhi in this year.

ITEM NO. 2/90 : CONFIRMATION OF THE MINUTES

The draft minutes of the 88th Governing Body (GB) meeting, held on 15th December 2020, were circulated to all the Hon'ble GB members for approval. The Hon'ble members have approved the minutes of 88th Governing Body meeting and the confirmed minutes were circulated to the members vide email letter dated 29th December 2021. The minutes of the 88th GB stands confirmed.

The minutes of 89th emergent Governing Body meeting, held on 13th March 2021, were approved as the resolution was finalized then and there. The minutes of the 89th GB stands confirmed.

ITEM NO. 3/90 : ACTION TAKEN REPORT

The members of the Governing Body noted about the actions taken in compliance to the decisions of the 88th meeting of Governing Body held on 15th December 2020:

- (i) Item No 6/88-A: Study Leave of Dr. Partha Sarthy Pal was further extended for a period of six months i.e. upto 4th July 2021 to pursue his research work at Germany.

- (ii) Item No 6/88-C: After the approval of the GB, the proposals of estimate for civil and electrical work etc. at the college were forwarded to DHE for release of fund for the same at the earliest.
- (iii) Item No 6/88-E: As per the Government orders the tender for engaging outsourcing agency for providing security and sanitation service in the college were to be floated through Government e-Market portal and the work on the same is in progress.
- (iv) Item No 6/88- G: As per the approval of the GB with respect to the date of acceptance of resignation of Ms. Harmeet Kaur from the post of Junior Assistant, the decision of the GB was forwarded to the University of Delhi for its approval.

ITEM NO . 4/90 : REPORTING ITEMS :

A. Appointment of University Representative(s) in the Governing Body of the College

The members of the Governing Body noted the appointment of University's Representative(s) namely Prof. Manoj Kumar, Department of Anthropology, University of Delhi and Prof. Subho Mozumdar, Department of Chemistry, University of Delhi, to represent the University under statute 30(1)(c)(i) of Statue of the University of Delhi, on the Governing Body of the College for a period of one year w.e.f. 25/02/2021 .

B. Appointment of Teachers Representative(s) in the Governing Body of the College

The members of the Governing Body noted the approval of University of Delhi regarding appointment of Dr. Inderbir Kaur, Associate Professor, Department of Electronics, BCAS, as Teacher's Representative on the Governing Body of the College for a period of one year with effect from 6th April 2021, under the category of teachers with more than 10 years of service.

C. Extension of the existing extended term of nominees on the Governing Body for further period of three months w.e.f. 13th June 2021

The members of the Governing Body noted that the Competent Authority, University of Delhi, has approved to extend the existing extended term of

nominee of Governing Body of the college for a further period of three months w.e.f. 13/06/2021 in term of clause 3(1) of Ordinance XVIII of the University.

D. To designate Principal of the College as Professor-Principal

The members of the Governing Body has noted and ratified that vide E.C. Resolution No. 47 (47-3) dated 08/12/2020, the Principal appointed as per the procedure/process outlined for the selection of a permanent Principal, in accordance with the Ordinance XVIII Clause 7(2)(a), shall be designated as Professor-Principal as conveyed vide letter dated 28/12/2020 of University of Delhi. The members, consequently, noted that Dr. Balaram Pani, Principal of the College has been designated as Professor-Principal.

E. Joining of Account Officer appointed by DHE in the College

The members of the Governing Body noted and ratified the appointment of Shri Praveen Gupta as Account Officer and he has been assigned charge of our college in addition to his own existing duties, initially for a period of six months, without any extra remuneration as conveyed vide Order No. F.3/2/2020-AC/576-608 dated 17/02/2021 of Finance Department, Govt. of NCT of Delhi. The members also noted that Shri Praveen Gupta, joined the college duties w.e.f. 01/03/2021 in the college as per the mentioned norms.

F. Auditing of the college accounts by the ELFA for the period from 1st April 2018 to 31st March 2020
